DISCLAIMER: MOTOR CITY GYMNASTICS LLC IS NOT RESPONSIBLE FOR ANY INJURY OR LOSS OF PROPERTY TO ANY PERSON WHILE PRACTICING, TRAINING, TAKING CLASS, COMPETING, PARTICIPATING IN OPEN GYM, SPECIAL EVENTS, DEMONSTRATIONS, OR SHOWS, OR IN ANY OTHER WAY INVOLVED IN GYMNASTICS, TUMBLING, PRESCHOOL, OR TEAMS AT MOTOR CITY GYMNASTICS LLC FOR ANY REASON WHATSOEVER, INCLUDING ORDINARY NEGLIGENCE ON THE PART OF MOTOR CITY GYMNASTICS LLC, ITS OWNERS, OFFICERS, AGENTS OR EMPLOYEES.

I hereby release and covenant not to sue Motor City Gymnastics LLC, the owners, and their employees and coaches for any claims resulting in personal wrongdoing or death as a result of my engaging in or receiving instruction in gymnastics, tumbling, or any other activities wherever, whenever or however the same may occur. I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and future; I may make that my family, my estate, heirs, or assigns. I am aware that gymnastics is a vigorous sporting activity involving the risk of personal injury and possible death. The risk of harm is limited by safety equipment and trained coaches but never eliminated.

I grant permission to the rights of my gymnast's image, likeness, and sound of his/her voice as recorded on audio or videotape without payment or any other consideration. I understand that my gymnast's image may be edited, published, or distributed, and I waive the right to approve the finished product. I understand my permission signifies that photographic or video recordings of my gymnast may be electronically displayed via the Internet, within the gym on site-specific monitors, or in an educational setting. This release applies to all photographic, audio, and video recordings collected after signing.

Furthermore, I have read Motor City Gymnastics's Policies and Procedures and agree to follow them to the best of my ability. I understand and acknowledge that my participation in gymnastics may expose me to various infectious diseases, including MRSA, Influenza, and COVID-19. Despite efforts to reduce the risk, there is still a possibility of serious illness or death. I willingly accept all known and unknown risks, even if they result from negligence, and take full responsibility for my participation and potential exposure.

If my child is transferring to Motor City Gymnastics from another competitive team, I will notify our current club about this decision.

I am aware this is a current release and indemnification of liability for my child(ren) and myself. Any prior agreements, oral or written, shall be void. A parent/guardian signed Waiver & Release of Liability Form is required for every participant and must be updated annually with the medical form.
